## Summary of 2019

- Sewer relining
- Sewer property discussion with Town of Berthoud
- Added a collar to the manhole near Carpenter's house to bring it up to grade
- Introduction of new homeowner's: Frazier's, Dempsey's and Kirmuss'

## Irrigation Committee Updates

- Homeowners should have winterized their valves by now
- Installation of approximately 6" to 8" pipe on Linnsens property
- Drainage ditch installation on West side of Hart's, Dempsey's, and Smith's to prevent further irrigation run off to the East
- Season stats:
  - 42 lots used irrigation water
  - 2,340 of 3,050 available inches were used
  - Big Elk Meadows Assoc. paid \$1,000 for the 8<sup>th</sup> year of their 10 year contract
- Goals:
  - Drainage for water overflow when irrigation water is running
  - Replacing meters with ones that are accurate at lower GPM usages

## 2020 Projects

- Review of lift station building
  - Facia is warped and needs removed or replaced
  - Siding needs to be fixed in places (bowed out and holes need to be filled)
  - Roof ridge needs re-nailed.
  - Needs a roof vent and soffit vents added (roof is jumbo shakes so might be ok for now)
  - Whole building needs to be scraped, sanded, caulked and painted
- Draft conveyance documents pursuant to Section 11 of the Agreement to Provide Residential Sewer service between River Glen HOA, Riverside Farm HOA and the Town of Berthoud
- Correct manholes that have been covered up
- Repair of damaged pavement on River View Drive
