# RIVER GLEN HOA BOARD MEETING MINUTES July 31, 2021 River Glen Common Area

- I. The meeting was called to order by President Dempsey at 9:03 AM.
- II. President Dempsey introduced Kelly McQueeney to the HOA attendees. Ms. McQueeney gave a summary of documents related to River Glen HOA and Larimer County.
  - 1. Resolution Concerning County Maintenance of Roads dated January 3, 1979 signed by Larimer County Board of County Commissioners
  - 2. Original plat for River Glen recorded July 2, 1973
  - 3. Letter from Larimer County Road and Bridge dated November 30, 2020

# Ms. McQueeney stated:

- 1. She had put in a request to the County for development documents but did not receive anything back.
- 2. The County says maintenance means only surface maintenance but there is no definition of maintenance in the Resolution.
- 3. She requested a similar resolution for Park Meadows subdivision and they have a definition of maintenance within their resolution which is dated December 27, 1989.
- 4. She also stated she was not aware of any actions where the County has assumed additional work.
- In River Glen's Amended and Restated Declaration of Covenants, Conditions and Restrictions, Article 5 Section K there is a reference to a Larimer County Subdivision Resolution adopted by the Larimer County Board of Commissioners dated August 24, 1972 that she was not able to find.
- 6. River Glen HOA can either fund the repairs through assessment to the Homeowners or through a Public Improvement District.

#### Questions and Answers:

Q - Is the 1979 Resolution still enforceable?

A – The County's position does not extend to repair and replace. They fall under the language noted in the Original plat.

- Q Is the condition of the roads due to failure to maintain?
- A The County's response is the roads are 40 years old it is the age of the roads not the maintenance.
- Q Can the County do an "advanced search" for the missing Resolution from 1972
- A They can request another search if we want them to.
- Q Anything in the agreement about what happens if we fail to respond to the repairs?
- A The Plat has language regarding the HOA's responsibility. The Resolution is not clearly defined.
- Q Would the County be responsible for maintenance of the roads if we repair them?
- A The County says they will do surface maintenance.
- Q What about the maintenance definition? What says the County will maintain them?
- A River Glen HOA needs to work with the County for a definition of maintenance.
- Q How do we enforce the maintenance? Some of our roads are not in bad condition?
- A Suggestion was made to set up a committee to review and research all options.

A motion was made by Mark McGee to set up a committee to research all options. The motion was amended by Ed Broestl to limit the number of people on the committee. The motion passed as amended with no dissents.

# III. Sewer Line Flushing 2021

Scott Canby gave a review of the timing for flushing the sewer lines. The flushing is done 1/3 of the subdivision at a time. Two thirds have been done and the remaining one third will be done next year then we will schedule to camera of the system again.

### IV. Irrigation Update

Daryl Musser said everything is running good right now.

#### V. Riverside Farms Second Filing

Slow progress on the second filing. River Glen HOA and Riverside Farms will be getting some fees when they tie into our lift station.

#### VI. Treasurer Review

Caroline White reviewed the 2021 Budget of approximately \$30,000. Through June 30, 2021 we have spent approximately \$10,000. Cash on hand as of June 30, 2021 is approximately \$43,000 and reserves required is \$40,000.
